## Objectives of the Company - there are 54 objectives as follows:

(1) To buy, procure, receive, rent, rent out, hire-purchase, hold ownership, own, improve, use and manage all types of assets and real estates as well as the profit of such assets.

- (2) To sell, sell on consignment, transfer, receive a transfer, mortgage, be a mortgage lender, pawn, be a pawnbroker, exchange and dispose of all assets and real estates as well as transfer and receive a transfer of legal rights for the benefit of the operation or any other business and take actions related to the real estate by being a broker or a representative of the deal or holding the ownership for other parties.
- (3) To act as broker, agent, commissioned agent in all kinds of businesses, except insurance business, solicitation of members for association, and trading of securities.
- (4) To borrow money, overdraw money from bank accounts, juristic persons, or other financial institutions, and to lend money or to grant credit by other methods, with or without securities, including receipt, issuance, transfer and endorsement of bills or other negotiable instruments.
- (5) To set up branch offices or to appoint agents both inside and outside the country.
- (6) To be a limited liabilities partner in limited partnerships or hold shares in other limited companies and/or listed companies and invest in all types of business and securities.
- (7) To operate business of trading in rice, rice products, tapiocas, tapioca products, corns, sesame seeds, peas, peppers, jutes, kenafs, cottons, lacs, castor beans, woods, rubbers, vegetables, fruits, forest products, herbs, animal leathers, animal horns, live animals, eviscerated meats, sugars, animal foods, and all kinds of agricultural produces.
- (8) To engage in business of trading in machinery, engines, mechanical equipment, labor-saving machines, vehicles, generators, and electrical appliances, refrigerators, air conditioners, fans, rice cookers, electric irons, water pumps, water heaters, coolers, kitchen utensils, iron wares, copper wares, brass wares, sanitary wares, hardware, furniture, electric equipment, plumbing equipment, including spare parts and accessories of above-said goods.
- (9) To engage in business of trading in fresh foods, dried foods, finished foods, canned foods, food flavors, beverages, liquors, beers, cigarettes, and other consumer goods.
- (10) To operate business of trading in fabrics, yarns, apparels, finished clothes, garments, adornments, cosmetics, beauty utensils and tools, and other consumer goods.
- (11) To operate business of trading in medicines for treating and preventing humans and animals from diseases, medical equipment, chemical equipment, medical and pharmaceutical devices, fertilizers, pesticides, plants and animals nourishments of all kinds, scientific tools and devices.
- (12) To operate business of trading in golds, alloy of gold and copper, silvers, diamonds, gems, and other precious stones, including the imitations thereof.
- (13) To operate business of trading in papers, stationeries, text books, printed forms, books, educational equipment, calculators, printing machines, printing equipment, printed matters, newspapers, filing cabinets, and office equipment of all kinds.

- (14) To operate business of trading in construction materials, tools and equipment used in construction works, craftsman's tools of all kinds, paints, painting equipment and building decorations of all kinds.
- (15) To operate business of trading in plastic or other things of similar nature, both in the state of raw materials or finished products.
- (16) To operate business of trading in raw rubbers, rubber sheets, or other types of rubbers produced or obtained from any part of Para rubber trees, including synthetic rubbers, imitations, materials or goods so mentioned through scientific process.
- (17) To operate business of rice fields, gardening farms, crops farms, salt farms, forestry farms, rubber plantations, animals rearing and livestock business.
- (18) To operate business of rice mills, sawmills, wood planning and curing factories, motorcar body factories, factories producing ceramics and enameled wares, factories producing earthen wares, jute baling factories, vegetable oils factories, paper mills, gunny bag factories, textile factories, yarn spinning factories, textile dyeing and printing factories, tyres and tyres retreading factories, steel factories, foundry and lathe factories, galvanized iron sheets factories, ready-made food factories, liquor distilleries, gas factories, cigarette factories, sugar mills, factories producing plastic goods, metal rolling and casting factories, factories producing doors and windows, glass factories, beverages factories, tyres retreading factories and car assembly factories.
- (19) To operate business of printing press, business of accepting the hire of work of printing books for sale and business of publishing newspapers.
- (20) To operate business of ice factories.
- (21) To operate business of fisheries, fish-piers and fish markets.
- (22) To operate business of rock blasting and stone quarrying.
- (23) To operate business of constructing buildings, commercial buildings, living quarters, offices, roads, bridges, dams, tunnels, and other construction works of all kinds, including civil works of all kinds.
- (24) To operate business of mining, factories of ores smelting, ores separating, ores conversion, ores casting, ores dressing, ores exploring, ores analyzing and examining, ores crushing and ores transportation.
- (25) To operate business of hotels, restaurants, bars, night clubs, bow ling arenas, massage parlors, theatres, and other amusement houses, resorts, sports grounds, swimming pools.
- (26) To operate business of transporting and handling of goods and passengers by land, water and air, both within the country and internationally, including the services of clearing goods from ports according to customs formalities, and freight transports of all kinds.
- (27) To operate business of tourism, including business in connection with tourism of all kinds.
- (28) To purchase, sell, and exchange foreign currencies (after having been authorized by the Ministry of Finance).

- (29) To import and export goods for sale according to that specified in the objectives.
- (30) To operate business of hair cutting, hair dressing, beautifying, tailoring and laundry.
- (31) To accept the hire of work of takin g photographs, as well as developing, printing and enlarging of pictures and documents.
- (32) To produce and sell movies.
- (33) To operate business of oil fuel service stations, and business of providing services of repairing, maintenance, inspecting, lubricating, anti-rust spraying, for vehicles of all kinds, including installation, inspection and repairing of equipment preventing every type of losses.
- (34) To operate business of providing services in law, accounting, engineering, architecture, and advertisement.
- (35) To operate business of guaranteeing debts, liabilities and performances under contracts of other persons, and guaranteeing persons entering or leaving the country under the law governing immigration, the law governing taxes and duties, and other laws.
- (36) To operate business of acting as consultant respecting problems concerning management, commerce, industry, including problems relating to production, marketing, and distribution.
- (37) To operate business of collecting, compiling, making, printing and publishing statistics and data of agriculture, industry, commerce, finance, marketing, including analysis and assessment of business operation.
- (38) To operate business of private hospitals, medical treatment establishments, and to admit patients for treatment, to provide technical instructions and training respecting medicines and sanitation.
- (39) To operate business of managing and taking care of benefits, collecting benefits, and managing property for other persons.
- (40) To operate business of submission of bids for sale of goods and acceptance of hire of work according to all objectives for persons, bodies of persons, juristic persons, government agencies and government organizations.
- (41) To operate business of constructing buildings for allocation as residential rooms for rent, or for business operation.
- (42) To engage in a business which involves sale of car, plot of land, house, commercial building, condominium, land trading, land allocation, housing estate and all types of buildings and divide land plot and building for sale.
- (43) To engage in a business which manage condominium building and juristic person of housing estate.
- (44) The company has the power to sell shares higher than the face value thereof.
- (45) The company has a right to issue securities, such as shares, debentures, bills, investment units, certificates showing right to buy debentures, certificates showing right to buy investment units or securities or any other instruments as specified or to be specified, as a result of the law governing public limited company or the law governing securities and exchange, for offering to the shareholders or to the public or any persons.

- (46) To operate business of private land surveying for the purpose of surveying land under the Land Code, and to act as consultant and agent in respect of land surveying, land allocation, land sale, and registration of condominium buildings.
- (47) Establish a real estate fund and/or the like and manage the fund as well as manage other relevant real estate funds.
- (48) Engage in a business which provides architectural design, landscape design, interior design and engineering services which directly and indirectly support the real estate development business of the Company.
- (49) Engage in business which provides advertisement service via computer systems, including internet system in the telecommunication system and other media such as magazines, newspapers, radio and television as well as design and produce all types of advertising media above and provide public relations services for business, education and public interest purposes.
- (50) Engage in business which provides event management, marketing promotion activities, sales and public relations services to an individual, a group of persons, juristic persons and governmental organizations.
- (51) Establish a school, educational institutions, sports field and sports training center and provide trainings and academic workshops on sports (when a license is obtained from relevant authorities).
- (52) Register, seek permission, buy, rent or acquire or dispose of patent, concessions, trademarks, mining concessions, certification marks, license or other copyrights.
- (53) Engage in condominium, housing estate and land allocation business, buy, sell, buy and sell by installments, buy and sell debts, rent out and hire-purchase condominium units, land plot or land plot with buildings.
- (54) Engage in nano finance business according to the announcement of the Bank of Thailand and other related announcements and engage in microfinance business (when approved by the government).
